TERMS AND CONDITIONS

1. Each lot will be sold to the highest bidder. The Owner, or owners' representative, has the right to "No-Sale" any lot until the animal leaves the ring. A No-sale fee will be charged.
2. The auctioneer in charge will settle any disputes as to bids, and his decision shall be final.
3. Terms are cash and payment is due from the purchaser immediately after the sale. Purchased animals will not be released until settlement is made. Checks are to be made payable to FCCA.
4. All stock will be ready for immediate shipment within the state of Florida; however, if the livestock is to be shipped to another state, the purchaser must comply with that state's laws. A sale veterinarian will be available to issue health certificates for interstate shipment. The horses in this sale have proof of a current, negative EIA "Coggins" test.
5. Each animal becomes the risk of the purchaser as soon as sold.
6. Livestock may be left at the sale facility overnight if arrangements are made. They must be removed from the facility by 1:00 p.m. the following Monday.
7. Inspection of the animals prior to the sale will begin at 9:00 a.m. on sale day.
8. Announcements from the auction box will take precedence over printed matter in this catalog. All livestock will be sold by lot number as announced from the auction block.
9. All persons who attend the sale do so at their own risk. The Sumter County Livestock Market and the Florida Cracker Cattle Association assume no liability, legal or otherwise, for the safety of the facilities or premises.
10. The Florida Cracker Cattle Association provides this service as agents only.
11. Load-out of stock will be in order assigned by sale staff. Participants will be patient and courteous to staff, volunteers and other buyers to facilitate an expedient load-out. Do not pull a stock trailer into the load-out line until you have your paid receipt in hand.
12. Buyers are to pick up Coggins and Registration Papers for each animal before leaving the Sale. This paperwork will be assembled into a folder for each buyer.
